And with around 1,100 tech startups, this city has about twice the average for other ecosystems at a similar development stage. In fact, one in four entrepreneurs in Melbourne have moved here from another country, specifically to launch a start-up. That's a very good sign!

Our Universities have bustling accelerator programs to incubate and develop new business ideas. And our Goods Shed Docklands area is just one precinct in which the thriving ecosystem successfully clusters.

But I am proud that innovation and entrepreneurship truly do not just reside in city warehouses. They are just as at home in Victoria's paddocks and wineries, regional food businesses, advanced manufacturing centres, defence and cyber tech capabilities and in our booming mining equipment and technology industry.

And so, what a pleasure it is, to see so many different business ventures here today: traversing sectors as diverse as medtech, health sciences, edtech, sports equipment, toys, fashion, STEM, volunteering and employment.

Today presents a perfect opportunity for our entrepreneurs to pitch their ideas. In the market, an idea alone is simply not enough. An entrepreneur must be able to sell the vision. To demonstrate the viability of their business and to garner support and backing.

What a perfect platform this format provides, in front of so many potential supporters, influencers, mentors, business partners and funders.

I must thank His Royal Highness for his vision, which lies behind the success of Pitch@Palace.

And also, RMIT's Vice-Chancellor and President, Martin Bean CBE, who has underpinned the vision here in Victoria.

It is important to thank today's judges for sharing their time and expertise to support and encourage the next generation of entrepreneurs.
